After getting the affiliation from CBSE New Delhi , the School Management will pay the salary to the teaching staff and non teaching staff as per the Government employee and other allowance will be paid through payee cheque and if not do this then this No Objection certificate will be withdrawn immediately.

5 You and your management assure in case the District Education Officer, or Education Department, or any senior Officer ask for any type of the Information the same be given to them and the same is given to the concerned authorities. If not do this then this No Objection certificate will be withdrawn immediately.
